

Non-EUREKA Member Participation

A non-EUREKA member country needs approval of the whole NPC-network Main procedural steps for the introduction of a non-member into a project

- The project leader submits a proposal to his NPC explaining that the requirements for a EUREKA project are met and describing why participation from a partner from a non-member country is beneficial to the project as a whole.

- The request will be subsequently submitted to the High Level Group (HLG) for approval; when the HLG is not in a position to make a decision, the request will be forwarded to the Ministerial Conference.
